

ORDINANCE NO. 29
AN ORDINANCE REVISING AND ESTABLISHING
ELECTORAL DISTRICTS FOR THE VILLAGE OF FLAT ROCK
FOLLOWING THE 2000 CENSUS

ARTICLE NO. I
AUTHORITY

This Ordinance is enacted by the Village Council of the Village of Flat Rock pursuant to the authority granted in N.C.G.S. ' 160A-23 and ' 160A-23.1 and the provisions of the Charter of the Village of Flat Rock. Village Council does hereby ordain and enact into law the following amendment to and modification of the electoral districts established for the Village of Flat Rock, North Carolina in the Charter of the Village of Flat Rock.

ARTICLE NO. II
ELECTORAL DISTRICTS

The electoral districts in which the members of the Village Council must reside as provided in Chapter III, Section 3.2 of the Charter of the Village of Flat Rock are modified and established as follows:

District 1: All of the geographical area lying West of U.S. Highway 25 and South of Little River Road. Essentially encompassing the subdivisions of Kenmure, Ravenswood, and Stonebridge.

District 2: All of that geographical area lying East of U.S. Highway 25, and in addition, that geographical area West of U. S. Highway 25 and North of Little River Road to the point of intersection of Laurelhurst Drive and Little River Road thence following a Northerly bearing along the Westernmost property line of the parcels which have been assigned PIN numbers by the Henderson County Land Records office as follows: 956772182755, 956761888055, 956762917255, 956774087455, 956775228555, 956775673455, 956776600555, 956776923655, 956777907755, 956787250455, 956787174455, 956788203555, 956788228555, 956788448055, 956788656655, and 956798430655 to the intersection of the Westernmost property line of 956798430655 and Erkwood Drive thence Southeasterly following the municipal border along Erkwood Drive and Rutledge Road to U.S. Highway 25. Essentially encompassing the subdivisions of Kingwood, Kingcrest, Claremont, Pinecrest, Bonclarken, Highland Lakes, Flat Rock Forest, Trenholm Woods and Dunroy.

District 3: All of that geographical area lying North of Little River Road and West of Laurelhurst Drive from the point of its intersection with Little River Road thence along Laurelhurst Drive on a Northerly bearing along the Westernmost property line of the parcels which have been assigned PIN numbers by the Henderson County Land Records office as follows: 9567722182755, 956761888055, 956762917255, 956774087455, 956775228555, 956775673455, 956776600555, 956776923655, 956777907755, 956787250455, 956787174455, 956788203555, 956788228555, 956788448055, 956788656655 and 956798430655 to the intersection of 956798430655 and Erkwood Drive. Essentially encompassing the subdivisions of Pleasant Hill, Woodhaven, Beaumont Estates, Flat Rock Lakes, Teneriffe, Tranquility and Chanteloupe.
